## **Installation of TS Performance Power Play MP-8 International DT444**

**Read all instructions and fully understand them before installing your TS Performance MP-8 module. Disconnect the battery terminals and remove keys from the ignition before installation. Place Di-Electric Grease onto every electrical connection.**



**TSP01DT Harness**

1. Locate a place to mount the MP-8 module inside the engine compartment on the driver's side where it will be free from extreme heat and moisture. Use the supplied zip-ties to securely mount the module.



2. Locate the Fuel Pressure Sensor on the driver's side of the engine block toward the front. The Fuel Pressure Sensor is under the tube running from the intercooler back to the engine.
3. Route the wire from the adjustable switch through the firewall to the module.
4. Mount the switch in the dash in a location the driver can access easily.
